## Section 4 - First Aid Measures

**Inhalation** Remove from exposure.

## Section 6 - Accidental Release Measures

**Spills & Disposal** Disposal of small spillages only. For large spillages liquids should be contained using sand or earth, and both liquids and solids then transferred to salvage containers. Residues should be treated as for small spillages. CAUTION: Before dealing with spillage take necessary protective measures, inform others to keep at a safe distance and, for flammable materials, shut off all possible sources of ignition. CARE! Spillages will be slippery. If local regulations permit, mop up with plenty of water and run to waste, diluting greatly with running water. Otherwise absorb on inert absorbent, transfer to container and arrange removal by disposals company. Wash site of spillage thoroughly with water. Ventilate area to dispel any residual vapours.

**Conditions for safe storage, including any incompatibilities** Store in a cool, well ventilated place. Store out of reach of children. Large quantities should be stored in a bunded area. Store in original container. Keep away from oxidising agents. Protect from physical damage. Clean up all spills and splashes promptly; avoid secondary accidents.

**Ingestion** May cause gastric upset, nausea, vomiting and diarrhoea. An aspiration risk.

**Inhalation** Inhalation of aerosols may cause cough. Aspiration of froth into the lungs during swallowing or vomiting may lead to chemical pneumonitis (irritation of lung tissues) and pulmonary oedema (fluid build-up in the lungs). Onset of symptoms may be delayed.

**Skin** Will have a degreasing effect on the skin which may lead to irritation on prolonged contact with the concentrate.

**Eye** Irritant.

**Chronic Effects** Repeated skin contact with the concentrate may lead to dermatitic effects.
