Section 6 - Accidental Release Measures

Spills & Disposal Disposal of small spillages only. For large spillages liquids should be contained using sand or earth, and both liquids and solids then transferred to salvage containers. Residues should be treated as for small spillages.
CAUTION: Before dealing with spillage take necessary protective measures, inform others to keep at a safe distance and, for flammable materials, shut off all possible sources of ignition. CARE! Spillages will be slippery. If local regulations permit, mop up with plenty of water and run to waste, diluting greatly with running water.
