**Emergency Procedures** Contain.

**Spills & Disposal** For large spills:  
Contain spillages with sand or earth. Transfer both liquid and solids to suitable container(s). Treat residues as for small spills.  
For small spills:  
If local regulations permit, mop up with plenty of water and run to waste, diluting greatly with running water. Otherwise, absorb on inert absorbent and transfer to suitable closed container. Wash site of spillage thoroughly with water and detergent.

**Conditions for safe storage, including any incompatibilities** Store in a cool, well ventilated place, out of reach of children. Large quantities should be stored in a bunded area. Store in original container. Keep container tightly closed and out of direct sunlight. Keep away from oxidising agents. Protect from physical damage. Do not allow to freeze. Clean up all spills and splashes promptly; avoid secondary accidents.

## Section 10 - Stability and Reactivity

**Chemical Stability** Stable under normal use conditons.
